PRODUCT DESCRIPTION

General purpose skin protection cream to help protect skin against heavy exposure to water and non-water based substances. Advanced formula contains special soil-suspending emulsifiers designed to make the skin easier and quicker to clean.

WHERE TO USE

Suitable for most workplaces to protect against heavy exposure to oil-based and water-based substances (such as oil, grease, lubricants and detergents) where gloves are not worn.

NB: Where possible skin exposure to potentially harmful substances and environments should be avoided through the implementation of safe working practices and the use of appropriate Personal Protective Equipment. Where skin exposure cannot be avoided, it is recommended to use an appropriate skin protection cream as part of a complete skin care programme to reduce the risk of occupational skin disease.

INSTRUCTIONS FOR USE

Before Working:

- Apply to clean and dry skin before starting each work period and after washing hands.
- Rub on all areas of the hands, including between the fingers and around the fingernails.

After Working:

- Prior to cleaning, apply a small amount of water to hands and rub together to loosen soiling then rinse with running water.
- This action will remove most of the soiling from the hands enabling the use of only a light cleanser to remove any remaining soiling.

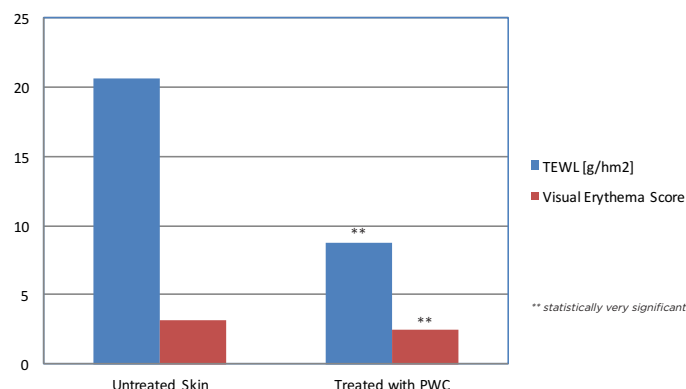
EFFICACY TESTS

Barrier Property Test

Repeated Occlusive Irritation Patch Testing using 14 healthy panellists was conducted using one water soluble substance (Sodium Lauryl Sulphate) and one non-water based substance (Ethyl Acetate/ Undecylenic Acid, 1:1). Each substance was applied at one time per day for 30 minutes over 5 days, alternating the water-based substance in the morning and non-water based in the afternoon.

Results (FIGURE 1) show Stokoderm® Advanced significantly reduces the Visual Skin Erythema and Trans Epidermal Water Loss (TEWL) compared to unprotected skin.

Hand Cleansing Test

Hand cleansing efficacy was tested using 10 healthy test panellists using a standardised model soiling (carbon black, iron oxide, graphite, petrolatum, oil, wax). Using only water to remove soil, the level of the residual dirt was assessed.

Results show that when rinsed with water alone, 86% of the soil is removed from the skin when the hands are pretreated with Stokoderm® Advanced.
